Dear Sir,

1. This refers to Gas Supply Agreement (GSA) dated [-----] between Buyer and Seller (GAIL (India) Limited) for the supply of gas to your plant at Agra / Ferozabad. In terms of Article 12.1 of the GSA, notice is hereby given to you as Buyer that the aforesaid GSA stands assigned to GAIL Gas Limited as the Seller, a wholly owned subsidiary of GAIL (India) Limited with effect from **16.11.2011**.
